_____ I, the undersigned, hereby apply for membership in the East Metro Association of REALTORS® and submit payment for dues and fees in the amount required. I understand that these dues, minus the application fee (if any), will be returned to me in the event that I am not accepted to membership, and that if accepted, initial and future dues are non-refundable. I agree as a condition of membership to complete the orientation course of the East Metro Association of REALTORS®, to thoroughly familiarize myself with the Code of Ethics of the National Association of REALTORS®, including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the East Metro Association and the Constitution, Bylaws and Rules and Regulations of the East Metro Association, the Oregon Association and the National Association.

_____ I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations and duty to arbitrate, all as from time to time amended. Finally, I consent and authorize the East Metro Association, through its Membership Committee or otherwise to invite and receive information and comment about me from any Member or other person, and I agree that any information and comment furnished to the East Metro Association by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

_____ I acknowledge that the Association will maintain a membership file of information which may be shared with other Associations where I subsequently seek membership. This file shall include: previous applications for membership; all final findings of Code of Ethics violations and violations of other membership duties within the past 3 years; pending complaints alleging violations of the Code of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures; pending arbitration requests; and information related to unpaid arbitration awards or unpaid financial obligations to the Association or its MLS.

_____ I acknowledge that if accepted as a member and subsequently resign from the Association or otherwise cause membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon my certification that I will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. I further understand that if I resign or otherwise cause membership to terminate, the duty to submit to arbitration continues in effect even after my membership lapses or is terminated, provided the dispute arose while I was a REALTOR®.

_____ I understand that I will become a provisional member immediately upon submission of a completed application form, dues and fees. Provisional membership is subject to all of the same privileges and obligations of membership and is granted subject to review of the application by the Board of Directors. If the Board of Directors determines that I have not met all of the qualifications established in the Association's bylaws, or if I do not satisfy all of the requirements of membership (for example, completion of a mandatory orientation program) within ninety (90) days of the Association's receipt of the application, my membership may be terminated.

_____ Further, I acknowledge that dues are computed from the date of application and are not refundable unless the Board of Directors terminates my membership for failure to meet the requirements of membership. In such instance, my dues will be returned, less a prorated amount to cover the number of days that services were received, and any application fee. **Dues are not refundable when a member leaves the business, area or member office.**

_____ I understand that it is a requirement for membership of the East Metro Association of REALTORS®, to notify the Association office of any change of contact information within seven (7) days of such change. Failing to meet the requirement may result in suspension of membership until the information is corrected.

_____ I acknowledge that ALL communications from EMAR, in the form of email, text message, etc. will not be unsubscribed or blocked. Furthermore, Email is the primary form of communication from EMAR and includes Constant Contact, Mail Chimp, and other systems which shall not be unsubscribed or blocked.

*According to the IRS, Oregon REALTORS® dues and NAR dues are not deductible as a charitable contribution. However, a portion of your dues may be deductible as an ordinary and necessary business expense... less the amount of dues allocated for federal and state lobbying expenses. The amount of dues directed to these operations for 2026 total **\$154.75 dollars** (NAR - \$55 and OAR - \$99.75) You should contact your CPA and/or tax professional for specific directions on how this relates to your taxable situation. Regardless of the deductible portion of your dues, the total amount of your annual REALTOR® dues are payable on the due date.*

The NAR Board of Directors at its annual meeting on June 5, 2025, approved NAR's 2026 budget which keeps the NAR dues unchanged at \$156/annual and \$45/annual special assessment for the Consumer Ad Campaign. The approved budget also reallocates \$35 of the special assessment for NAR's general operating account. The remaining \$10 will go towards the Consumer Ad Campaign.

*A portion of your Oregon REALTOR® dues includes a \$50 allocation into the *Oregon REALTOR® Political Action Committee (ORPAC). However, you may choose to re-allocate \$50 of your total Oregon Realtor® dues – to either the HOME Foundation or the Issues Mobilization Fund by sending an email message to redirect@oregonrealtors.org and specifying your choice. Any re-direct requests MUST be made within 48 hours of the time dues are paid. Redirect requests received after the 48-hour time frame of payment will not be honored. Please note, ORS 316.102 may provide for a credit against Oregon state taxes of up to \$50 per individual or \$100 per joint return for contribution to political committees, including ORPAC. If you have further questions or concerns, please call 503-362-3645.*

**In 2024, the Oregon Legislature passed campaign finance reform (HB 4024) limiting the amounts that political action committees can contribute to candidates. This new law allows associations such as Oregon REALTORS® to operate a traditional political action committee (PAC) as well as a new type of political action committee called a “Small Donor Political Committee.” Small Donor Political Committees cannot accept contributions in excess of \$250 but are subject to less stringent limits on the amounts they can contribute to candidates. Oregon REALTORS® has established a second political action committee (Oregon REALTORS® Political Action Committee 2, or ORPAC2) that will operate as a Small Donor Political Committee. The \$50 allocation will go to ORPAC2.*

As part of the application process, all brand-new REALTOR® Members who have never belonged to another REALTOR® association are required to complete a REALTOR® Code of Ethics New Member Course, a Fair Housing training and an EMAR Orientation class as a condition of REALTOR® membership.
